

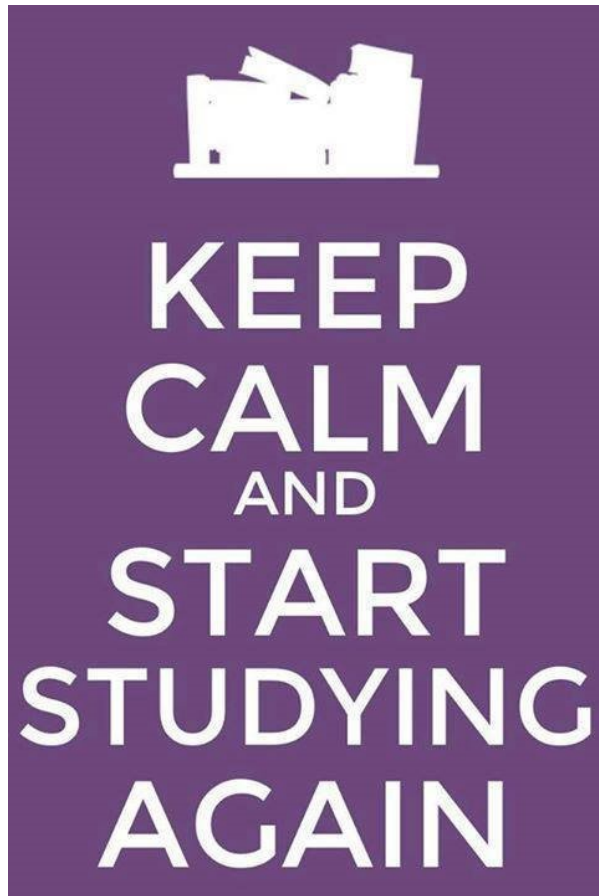

Nicole Meador will be working the front office area, and assisting the S8 and PH programs.

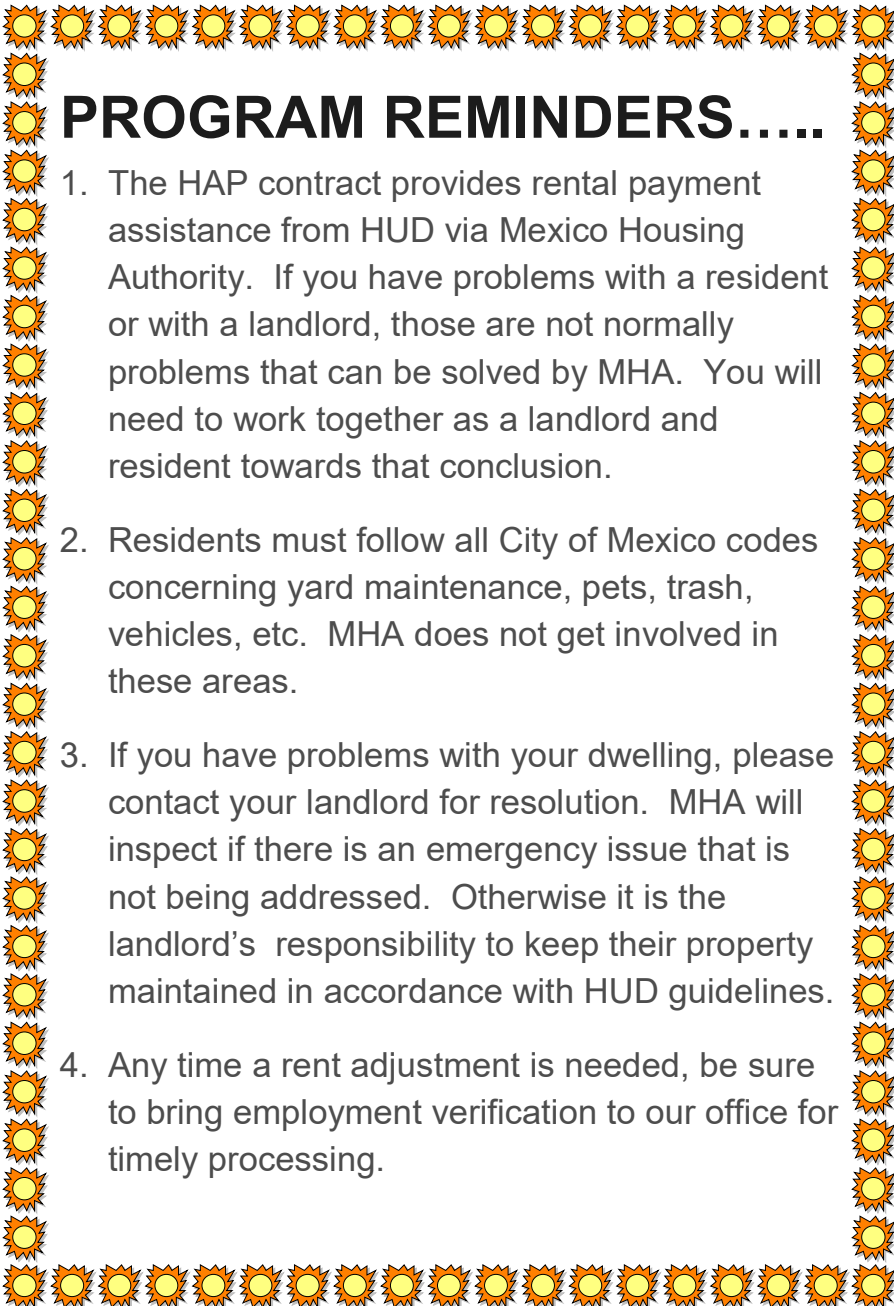

PROGRAM REMINDERS.....

1. The HAP contract provides rental payment assistance from HUD via Mexico Housing Authority. If you have problems with a resident or with a landlord, those are not normally problems that can be solved by MHA. You will need to work together as a landlord and resident towards that conclusion.
2. Residents must follow all City of Mexico codes concerning yard maintenance, pets, trash, vehicles, etc. MHA does not get involved in these areas.
3. If you have problems with your dwelling, please contact your landlord for resolution. MHA will inspect if there is an emergency issue that is not being addressed. Otherwise it is the landlord’s responsibility to keep their property maintained in accordance with HUD guidelines.
4. Any time a rent adjustment is needed, be sure to bring employment verification to our office for timely processing.
